Fayette County School Corporation is providing and administering an insurance program for students as part of our one-to-one learning, engagement, and technology initiative. This plan covers "accidental damage" to the iPad and is designed to limit a family's financial responsibility for any damages as described in the coverage section below.

| <ul style="list-style-type: none"> ❖ Accidental Damage: Pays for accidental damage caused by liquid spills, drops, or any other unintentional damage. ❖ Theft: Pays for hardware replacement only in the event of loss or damage due to theft; the claim requires a police report to be filed and copy of the report accompanied with the claim. ❖ Fire: Pays for hardware replacement only in the event of loss or damage due to fire; the claim requires a fire report from an investigating authority and copy of the report accompanied with the claim. ❖ Electrical Surge: Pays for hardware replacement only in the event of damage due to an electrical surge. ❖ Natural Disasters: Pays for hardware replacement only in the event of loss or damage due to natural disasters. | <ul style="list-style-type: none"> ❖ Dishonest, Fraudulent, Intentional, Negligent, or Criminal Acts: Will not pay if damage or loss occurs in conjunction with a dishonest, fraudulent, intentional, negligent or criminal act. Will not pay if damage or loss occurs as a result of violating Board Policy, state, or federal statute or regulation. The student, parent or guardian will be responsible for the full amount of the repair or replacement. ❖ Consumables: Including but not limited to power charger, USB cable, and apps/software. 10W Power Adapter...\$14 USB Cable...\$9 ❖ Cosmetic damage: If it does not affect the functionality of the iPad, a claim will not pay. This includes but is not limited to scratches, dents, or broken port covers. |

Renewing coverage in consecutive, subsequent school years will be offered at a discount if there was no damage or claims filed in the previous school year. Premium for renewed coverage may be discounted by \$20 e.g. renewal premium of \$25.
